#### **Advanced notice – validation changes for VET Provider Collection**

NCVER is looking to implement the following improvements in a future 2020 release. More information will be provided as their implementation dates are identified:

- As advised in previous notifications, existing warning (4758) will no longer trigger for credit transfer outcomes.
- Warnings will be triggered when a postcode of 'OSPC' has been identified but the Address suburb, locality or town matches location specified by Australia Post. These warnings will not prevent the submission of data.
- All AVS users will be able to see a list of users associated with their organisation, as well as what AVS functions each user can perform.

## Validation changes for VET Provider Collection

The following validation changes will be implemented in AVS by the end of December 2019:

This rule checks that the Date program completed does not fall after the collection period end date. For state training authorities, the rule currently runs as an error for all collection periods. This is being updated, so that for quarterly collections only, the rule will run as a warning. It will continue to be an error for the annual (i.e. January-December) collections. This is in line with how the rule already runs for registered training organisations.

Previously we advised new errors were coming in 2020, triggering when a postcode of 'OSPC' has been identified but the Address – suburb, locality or town matches location specified by Australia Post. The introduction of these rules have been postponed until a later date.

#### **AVS changes**

The Export Files function will be removed from AVS in December 2019. AVS users should ensure they can easily locate the file sets they have used for validation.

## **USI Transcript Update Tool - changes to emails**

By the end of the year, emails sent to RTO's after using the USI Transcript Update Tool will no longer include details of the changes that were made. A full history of edits applied from your RTO can still be accessed by logging into the USI Transcript Update Tool via AVS.

## **Classifications updated for 2020 data - VET Provider Collection**

A reminder that changes to *Funding source – national*'s classification scheme come into effect for 2020 collection periods. '30 – International client – other revenue' will no longer be valid, and is being replaced by two new codes – '31 – International onshore client – other revenue' and '32 – International offshore client – other revenue'. Please see our <u>Data element definitions document</u> for the full classification scheme.

#### Jan-Dec 2019 collection (due early 2020)

The 2019 collection of AVETMISS data (due early 2020) must still report international clients using the 30 code.

#### Jan-Mar 2020 collection and following

The 30 code will no longer be valid, and the 31 and 32 codes must be used in their place. This applies to all 2020 activity, including that started prior to, and continues into, 2020.

If data submitters are struggling to report in the new format, particularly in the early stages of the year, when they may be reporting 2019 and 2020 data at the same time, please contact our <u>Client</u> <u>Support</u> team for assistance.

#### Advanced notice - validation changes for VET Provider Collection

NCVER is looking to implement the following improvements in a future release, by 2020. More information will be provided as their implementation dates are identified:

- New errors ensuring that when a postcode of 'OSPC' has been identified, that the Address suburb, locality or town cannot match to a location specified by Australia Post. This is to ensure that the 'OSPC' postcode has not been entered mistakenly.
- New error ensuring that where new Funding Source values '31 International onshore client other revenue' and '32 International offshore client other revenue' are used, that the

client's postcode is OSPC. This is to ensure that RTOs are inputting the client's usual home address, not their temporary Australian residence.

- New error ensuring that where Funding Source value = '31 International onshore client other revenue', then the Training organisation delivery location postcode must not be OSPC.
- The Export Files function will be removed from AVS. AVS users should ensure they can easily locate the file sets they have used for validation.
- Existing error 3242 (which triggers when the Date program completed is after the collection period end date) will become a warning for state training authorities when validating quarterly collections. It is already a warning for RTOs when using the quarterly collection periods. The rule will remain an error for all data submitters when submitting to the annual (i.e. January-December) collection.

   Supplementary files can now replace standard versions on upload and vice versa. An upload of a zip file containing both types (e.g. NAT00030 and NAT00030A) will still trigger an upload error.
- To prevent orphan subjects on the USI transcript when a registered training organisation stops operating, the latest version of AVETMISS allows the reporting of subjects as '41 – Withdrawn/discontinued due to RTO closure'. AVS will display all records related to this rule to enable the user to identify and amend training activity accordingly.

These rules have been implemented to make quarterly reporting easier for RTOs that submit directly to NCVER to update student transcripts. Quarterly submissions from RTOs submitting directly to NCVER remain optional. Please refer to our <u>AVETMISS: Quarterly reporting fact sheet</u> for further information.

It's important to note that it still won't be possible to submit activity starting after the collection period end date when submitting to the annual (Jan-Dec) collection. When submitting to the annual collection you will need to provide the data as it was on the 31<sup>st</sup> of December for the collection year, not as it is at the time of submission.

If your data are submitted to a third-party agency, who forwards that data to NCVER (such as a government department responsible for VET) they may require you to submit the data as it was at the end of that quarterly period.

For example, if you're submitting to the Jan-Mar collection, they may want to see your data as it was on the 31 March. If this is the case, you can use the *Enforce collection period dates* check box (pictured) to identify and prevent any activity that commenced after 31 March from being included in your data. This is unchecked by default.

This will mean that validation rules 3211 and 3242 will run as errors – instead of warnings – more easily highlighting records that start after the collection period end date. Please <u>contact</u> the agency you are submitting to and confirm their requirements.

To hide records that <u>can't</u> be clicked on set the Latest only filter option to 'Yes'. The Collections window, on the home screen, will continue to only ever show the latest record for each collection.

Some records will have a check box next to them (pictured, highlighted). Checking this box will allow the collection to be reset by clicking Reset at the bottom of the screen. This function can be useful in situations where a collection gets stuck in a status (e.g. uploading for 2 days).

## **Changes – April 2018**

#### **Optional quarterly reporting in AVS – further information**

From May 2018, AVS will allow RTOs to report their fee-for-service data to NCVER's quarterly collection periods (Jan-Mar, Jan-Jun and Jan-Sep). Until now, RTOs have been able to validate using these collection periods, but not to submit.

More frequent reporting allows students' training activity to appear on USI Transcripts earlier than waiting for the annual collection. This more frequent reporting is optional, and RTOs must still submit all data to the annual (January-December) collection.

RTOs should note the following if they choose to report on a quarterly basis:

- If you report to a quarterly collection, this does not lock you in to reporting to subsequent quarterly collections for example, if you choose to report to the Jan-Mar collection, it is not mandatory to continue reporting to the Jan-Jun or Jan-Sep collection; you will still need to submit all data to the annual (January-December) collection.
- Any reporting throughout the collection year is cumulative for example, if an RTO chooses to report to the Jan-Mar collection, and then chooses to report to the Jan-Jun collection, the Jan-Mar data must also be included in the Jan-Jun submission. Excluding it from any subsequent submissions will result in the data being deleted from the USI Transcript, as each submission overwrites anything submitted to previous quarters.

Quarterly collections open approximately six weeks following the end of each quarter and remain open for two weeks. Exact dates will be communicated in NCVER's <u>data support bulletins</u>. To report to the quarterly collection, RTOs simply need to validate for the quarter as per normal, proceed to the Finalise Submission screen and submit in the same manner as they currently do for the annual collection.

RTOs who already submit their funded data to state training authorities on a regular basis should continue to do so; they are not affected by this process.

Data submitters should ensure they are <u>subscribed</u> to NCVER's Data Support Bulletin to be advised of reporting timelines and any changes in this process. For more information refer to NCVER's <u>Fact</u> <u>Sheet</u> on quarterly reporting.

#### New Unique student identifier value

As of 21 August 2017, registered training organisations (RTOs) reporting clients who have individual exemptions from the Unique Student Identifier (USI) scheme for genuine personal reasons have been able to use the standardised exemption code 'INDIV'. It is important to note that RTOs MUST sight the exemption document issued by the USI Office for each of these students. This process will replace the need for you to obtain a special 10-digit alpha-numeric code from the USI Office to use in place of a USI when submitting AVETMISS data for exempted clients. As is the case with the current special code, exempted clients reported with the INDIV code instead of a USI will not be able to obtain a USI transcript from the USI Registrar.

#### When can you use the INDIV exemption code?

**2017 reporting**: RTOs reporting on clients who have already been reported using the 10-digit special USI exemption code may EITHER use the special code or the 'INDIV' code for 2017 AVETMISS reporting.

**2018 reporting**: From 1 January 2018 onwards all genuine individual exemptions from the USI scheme must be reported using the 'INDIV' code.

#### Key things to remember:

1. The 'INDIV' code, along with the 10-digit special USI exemption code and other exemption codes 'INTOFF' and 'SHORT' must not be attempted to be verified in the USI Registry System.

2. The USI Office will be closely monitoring the use of the INDIV code and it is only to be used for genuine objectors. Suspected misuse of the INDIV code will be followed up by the Regulators and the USI Office.

#### Advance notice - validation changes for VET Provider Collection

New *Unique student identifier* validation on blank USIs will be introduced for the first collection under Release 8.0 (in effect from 1 January 2018).

A new validation error will be triggered where, within a submission, the data submitter has surpassed a predetermined percentage of blank USIs. This predetermined percentage value is subject to change. This error will only run when the data has a client count of at least 100.

This new error is in addition to existing Error 3864 which triggers on any record where the client has a blank USI, and they have been reported with an issued program completion for a nationally recognised program.

A validation warning will still be triggered if the submission has not triggered either of the aforementioned errors, but the data contains records which are eligible for a USI. Validation warnings do not prevent submission of data via AVS.

To access this feature, simply select Year '2018' and Collection Period 'Jan-Mar' from the Collection Processing screen in AVS. Release 8.0 validation rules are also available from this screen.
