



Introduction

NCVER introduced a number of data quality checks and reports from 2016 into the AVETMISS Validation Software (AVS) to enable State training authorities (STAs) and Boards of Studies (BoSs) to self-assess the quality of their data prior to submission to the annual National VET Provider and VET in Schools Collections. From 2019, these data quality checks and reports will also be applied to quarterly submissions to the National VET Provider Collection for STAs.

Data quality exemptions

Where data quality checks generate a data quality error that prevents the data being submitted, the data submitter may apply to NCVER for a data quality exemption through the Collection Details page within AVS. For STA quarterly submissions (Q1-Q3), the data quality exemptions are automatically approved unlike in the annual collections where they are approved by NCVER’s Collection coordinator. Once the exemption has been granted, the data submitter will need to re-validate the data in AVS. If the data is resubmitted, the exemption will need to be requested and applied again.

The following tables provide a list of these data quality checks and reports, outlining when they are applied¹.

- the term 'data collection' used throughout the data quality checks refers to either the National VET Provider or VET in Schools (VIS) collections.
- where the data quality check or report refers to the:
 - previous annual data collection means the previous year's January – December [Q4] data collection (e.g. current: 2019 Jan-Mar [Q1] versus previous: 2018 Jan-Dec [Q4]).
 - previous corresponding quarter means the previous year's corresponding quarter (e.g. current: 2019 Jan-Mar [Q1] versus previous: 2018 Jan-Mar [Q1])
