# Total VET students and courses 2021

National Centre for Vocational Education Research



## **Highlights**

In 2021:

- 4.3 million students were enrolled in nationally recognised vocational education and training (VET), up 9.0% from 2020
- 3529 registered training organisations (RTOs) delivered nationally recognised VET
- an estimated 24.0% of the Australian resident population aged 15 to 64 years participated in nationally recognised VET in Australia.

In 2021, compared with 2020:

- full-year training equivalents (FYTEs) increased by 12.0% to 1.1 million
- students enrolled in nationally recognised programs increased by 4.4% to 2.1 million
- students enrolled in subjects not delivered as part of a nationally recognised program increased by 14.7% to 2.7 million.

By funding source:

- government-funded students increased by 4.5% to 1.4 million and FYTEs increased by 11.0% to 548 500
- domestic fee-for-service students increased by 13.1% to 3.2 million and FYTEs increased by 15.5% to 448 600
- international fee-for-service students decreased by 4.3% to 213 000 and FYTEs increased by 5.6% to 146 800.

## Students and full-year training equivalents (FYTEs)

In 2021, 4.3 million students were enrolled in nationally recognised VET.

An estimated 24.0% of the Australian resident population aged 15 to 64 years participated in nationally recognised training in 2021. Participation was highest among those aged 15 to 19 years (at 44.6%) followed by those aged 20 to 24 years (at 34.9%).

Some students enrolled in one or more programs, others in subjects that were not part of a nationally recognised program, and many in a combination of both. The number of students enrolled in programs in 2021 increased slightly compared to the previous year. The number enrolled in shorter, stand-alone subjects has increased in 2021 to the highest number in the last five years.





Figure 1 Students enrolled in nationally recognised training, 2017 to 2021 ('000)

The sum of students (n= 4.9 million in 2021) will not add to the 2021 total (4.3 million) as a student may have enrolled in multiple types of training in a calendar year.

- In 2021, compared with 2020, the number of FYTEs enrolled in:
- nationally recognised programs increased by 11.2% to 965 900
- subjects not delivered as part of a nationally recognised program increased by 16.6% to 178 000.


Figure 2 FYTEs in nationally recognised training, 2017 to 2021 ('000)



In 2021, 2.1 million students (49.9%) were enrolled in nationally recognised programs, consisting of:

- training package qualifications (1.9 million students)
- accredited qualifications (160 300 students)
- training package skill sets (86 800 students)
- accredited courses (96 300 students).


### Figure 3 Students enrolled in nationally recognised programs, 2021 ('000)

In 2021, 2.7 million students (63.5%) enrolled in subjects that were not delivered as part of a nationally recognised program. These students had a total of 7.0 million subject enrolments (24.1% of all subject enrolments), of which the top six were all within the Health training package.

## **Participation rates**

24.0% of the Australian resident population aged 15 to 64 years and 44.6% of the Australian resident population aged 15 to 19 years participated in nationally recognised VET in 2021, an increase from 21.7% in 2020 and higher than pre-Covid levels (23.4% in 2019). Queensland has the highest participation rate for VET students aged 15 to 64 years (28.0%).

Usual residential address refers to where the student usually resides rather than a temporary address a student relocates to for training, work, or other purposes.

## **Funding source**

### **Students**

VET students can undertake training as a full fee-paying student (domestic or international fee-for-service) or with the assistance of a government subsidy (government-funded).

In 2021, compared with 2020, the number of government-funded students increased by 4.5% to 1.4 million. Domestic fee-for-service students increased by 13.1% to 3.2 million following a decrease from 2019 to 2020. International fee-for-service students decreased by 4.3% to 213 000.




Figure 5 Students enrolled in nationally recognised training, 2017 to 2021 ('000)

In 2021:

- 58.5% of students enrolled in training package qualifications were government-funded
- 95.4% of students enrolled in subjects not delivered as part of a nationally recognised program were domestic fee-for-service funded.

### Full-year training equivalents (FYTEs)

In 2021, compared with 2020, government-funded FYTEs increased by 11.0% to 548 500 to return to 2019 levels following a drop in 2020, domestic fee-for-service FYTEs increased by 15.5% to 448 600 after several years of decline and international fee-for-service FYTEs increased by 5.6% to 146 800.




Figure 6 FYTEs by funding source, 2017 to 2021 ('000)

In 2021:


- 53.3% of FYTEs in training package qualifications were government-funded
- 88.2% of FYTEs in subjects not delivered as part of a nationally recognised program were domestic fee-for-service funded.

### Students in nationally recognised programs

In 2021, compared with 2020, the number of students enrolled in nationally recognised programs increased by 4.4% to 2.1 million. Government-funded students increased by 7.0% to 1.2 million and domestic fee-for-service students increased by 3.2% to 821 700. In contrast, international fee-for-service students decreased by 3.9% to 206 400.

### Students in subjects not delivered as part of a nationally recognised program

In 2021, compared with 2020, the number of students enrolled in subjects not delivered as part of a nationally recognised program increased by 14.7% to 2.7 million. Government-funded students decreased by 9.4% to 158 800 and domestic fee-for-service students increased by 16.7% to 2.6 million following a decline in 2020. International fee-for-service students decreased by 9.4% to 9 400.





Figure 8 Students enrolled in subjects not delivered as part of a nationally recognised program by funding source, 2017 to 2021 ('000)

## **Provider type**

In 2021, 3.2 million students (74.1%) were enrolled in nationally recognised training at private training providers, 778 300 (18.1%) at TAFE institutes, 449 500 (10.5%) at community education providers, 114 100 (2.7%) at schools, 107 000 (2.5%) at enterprise providers and 75 600 (1.8%) at universities.

In 2021, 695 000 (60.8%) FYTEs were enrolled in nationally recognised training at private training providers, 304 300 (26.6%) at TAFE institutes, 42 500 (3.7%) at schools, 45 400 (4.0%) at community education providers, 37 400 (3.3%) at universities and 19 400 (1.7%) at enterprise providers.




Figure 10 FYTEs by provider type, 2017 to 2021 ('000)

### **Provider counts**

In 2021, there were 3529 registered training organisations (RTOs) that had an active registration and delivered nationally recognised VET.

The sum of training providers across state/territory and offshore delivery locations will not add to 'Australia' as a training provider may deliver in multiple locations in a calendar year.

## **Program enrolments and completions**

In 2021, there were 2.8 million enrolments in nationally recognised programs. 92.6% of these were in qualifications: 86.1% in training package qualifications and 6.5% in accredited qualifications. Compared with 2020, training package qualifications increased by 6.3% to 2 385 400, accredited qualifications increased by 6.6% to 181 300, training package skill sets decreased by 24.3% to 91 600 and accredited courses increased by 10.4% to 113 100.




Figure 11 Nationally recognised program enrolments by type of training, 2017 to 2021 ('000)

### **Qualification enrolments**

In 2021, Management and commerce was the most popular field of education, comprising 21.7% of all qualification enrolments. This was followed by Society and culture (19.7%) and Engineering and related technologies (16.0%).

In 2021, the highest number of qualification enrolments were in certificate III level qualifications (39.4%), followed by certificate IV (20.0%), and certificate II (18.8%).




Figure 13 Qualification enrolments by level of education, 2017 to 2021 ('000)

### **Qualification completions**

Preliminary numbers show 751 300 qualification completions in 2021. This number will be revised upwards with the release of *Total VET students and courses* 2022.

In 2021, the highest number of qualification completions were at certificate III level (34.4% of all qualification completions), followed by certificate II (21.5%), and certificate IV (20.5%).




Figure 14 Qualification completions by level of education, 2017 to 2021 ('000)






Figure 16 FYTEs in nationally recognised training, 2015 to 2021 ('000)
