

Australian vocational education and training statistics

Government-funded students and

courses - January to June 2024

National Centre for Vocational Education Research

Highlights

In the six months ending 30 June 2024, 929 810 students were enrolled in government-funded vocational education and training (VET) in Australia. They included:

- 900 810 students enrolled in nationally recognised training
- 44 870 students enrolled in non-nationally recognised training.

There were 1 035 605 government-funded program enrolments in Australia comprised of:

• 93.8% in nationally recognised programs

- 89.2% were in qualifications: 81.1% in training package qualifications and 8.1% in accredited qualifications


- 4.6% were in training package skill sets and accredited courses
- 3.7% in locally developed programs
- 2.5% in non-nationally recognised programs.

In the six months ending 30 June 2024, there were 923 250 government-funded nationally recognised qualification enrolments in Australia. The most popular level of education was Certificate III (463 680 or 50.2%), followed by Certificate IV (186 245 or 20.2%).



Students

In the six months ending 30 June 2024, 929 810 students were enrolled in government-funded VET in Australia, an increase of 2.0% from the same period in 2023.



Note: This chart shows the overall picture of Australia and does not update based on state/territory selection.

In the six months ending 30 June 2024, 900 810 government-funded students were enrolled in nationally recognised VET, consisting of:


- training package qualifications (780 280 students or 86.6%)
- accredited qualifications (76 430 students or 8.5%)
- training package skill sets (9 270 students or 1.0%)
- accredited courses (32 265 students or 3.6%)

• locally developed skill sets and courses comprised of at least one nationally recognised subject (34 305 students or 3.8%)

• stand-alone nationally recognised subjects (10 545 students or 1.2%).

Note that students are enrolled in one or more programs, others in stand-alone subjects, and some in a combination of both.

In the six months ending 30 June 2024, 44 870 government-funded students were enrolled in nonnationally recognised VET, consisting of:

- non-nationally recognised programs (25 175 students)
- higher education qualifications (0 students)
- stand-alone non-nationally recognised subjects (19 860 students).

Full-year training equivalents (FYTEs)

In the six months ending 30 June 2024, there were 224 830 FYTEs in government-funded nationally recognised VET in Australia. The majority of these were within Training package qualifications (199 710 or 88.8%), followed by Accredited qualifications (15 790 or 7.0%).

In the six months ending 30 June 2024, there were 5 330 FYTEs in government-funded non-nationally recognised VET in Australia, consisting of:

• 4 300 FYTEs in non-nationally recognised programs including higher education qualifications

• 1 030 FYTEs in non-nationally recognised stand-alone subjects.

Provider reporting type

In the six months ending 30 June 2024, 1 377 providers were delivering government-funded VET in Australia, an increase of 2.9% from the same period in 2023.


Note: The total is a distinct count of training providers that submitted data through the state training authorities. Some training providers deliver VET in more than one state or territory and may be classified against multiple provider reporting type classifications, but only counted once in the total.

Students by provider reporting type

Of the 929 810 students enrolled in government-funded VET in Australia:

- 506 835 or 54.5% were enrolled at TAFE institutes (up 5.6% from January to June 2023)
- 43 570 or 4.7% at other government providers (up 11.0%)
- 44 745 or 4.8% at community education providers (up 2.2%)
- 304 900 or 32.8% at private training providers (down 3.7%)
- 52 055 or 5.6% at other training providers (down 4.5%).

Program enrolments


In the six months ending 30 June 2024, there were 1 035 605 government-funded program enrolments in Australia, an increase of 1.9% from the same period in 2023. Of these:

• 89.2% were in qualifications, including training package qualifications (81.1%) and accredited qualifications (8.1%)

- 4.6% were in training package skill sets and accredited courses
- 3.7% were in locally developed programs comprised of at least one nationally recognised subject
- 2.5% were in non-nationally recognised programs.


In the six months ending 30 June 2024, the most popular field of education was Engineering and related technologies (184 185 or 17.8%), followed by Society and culture (154 310 or 14.9%).


Figure 5 Government-funded program enrolments by field of education, January to June 2023 and 2024, Australia

In the six months ending 30 June 2024, there were 923 250 government-funded nationally recognised qualification enrolments in Australia (up 3.1% from the same period in 2023). The most popular level of education was Certificate III (463 680 or 50.2%), followed by Certificate IV (186 245 or 20.2%).






Note: Data in the figure above are based on training package qualifications and accredited qualifications only. Other programs such as training package skill sets and accredited courses are excluded.

In the six months ending 30 June 2024, Community Services had the highest number of training package enrolments (198 170 or 23.5%), followed by Construction, Plumbing & Services Integrated Framework (91 190 or 10.8%).

Subject Enrolments


In the six months ending 30 June 2024, there were 6 711 735 enrolments in government-funded VET subjects in Australia.

Of these, 59 670 (0.9%) were in stand-alone subjects, consisting of:

• 23 405 stand-alone nationally recognised subjects, which are comprised of units of competency and accredited units


• 36 260 stand-alone non-nationally recognised subjects, which are comprised of units of competency and modules.
