# **Total VET students and courses** 2022





# **Highlights**

In 2022, 4.5 million students were enrolled in nationally recognised vocational education and training (VET), up 5.1% from 2021. They included:

- 2.1 million students enrolled in nationally recognised programs
- 3.0 million students enrolled in subjects not delivered as part of a nationally recognised program.

In 2022, compared with 2021:

- Student numbers increased by 5.1%
- Full-year training equivalents (FYTEs) increased by 0.3% to 1.1 million
- Students enrolled in nationally recognised programs decreased by 1.3%
- Students enrolled in subjects not delivered as part of a nationally recognised program increased by 10.4%.

An estimated 25.0% of the Australian resident population aged 15 to 64 years participated in nationally recognised VET.

Over the five-year period from 2018 to 2022, student numbers increased by 11.3%.

# Students and full-year training equivalents (FYTEs)


In 2022, 4.5 million students were enrolled in nationally recognised VET.

Some students enrolled in one or more programs, some in subjects that were not part of a nationally recognised program, and others in a combination of both.

In 2022, compared to 2021, students enrolled in:

- nationally recognised programs decreased 1.3% to 2.1 million
- subjects not delivered as part of a nationally recognised program increased 10.4% to 3.0 million.

Figure 1 Students enrolled in nationally recognised training, 2018 to 2022 ('000)





Full-year training equivalents, or FYTEs, are a measure of activity undertaken by students on a full-time basis within a year. One FYTE is equal to 720 reporting hours.

In 2022, compared with 2021, the number of FYTEs in:

- nationally recognised programs decreased by 0.2% to 965 895
- subjects not delivered as part of a nationally recognised program increased by 3.0% to 183 870.


Figure 2 FYTEs in nationally recognised training, 2018 to 2022 ('000)



In 2022, 2.1 million students (46.9%) were enrolled in nationally recognised programs, consisting of:

- training package qualifications (1.8 million students)
- accredited qualifications (157 400 students)
- training package skill sets (104 185 students)
- accredited courses (107 105 students).


Figure 3 Students enrolled in nationally recognised programs, 2022 ('000)

In 2022, 3.0 million students (66.7%) enrolled in subjects that were not delivered as part of a nationally recognised program. These students had a total of 7.3 million subject enrolments (25.5% of all subject enrolments).

# **Participation rates**

In 2022, 25.0% of the Australian resident population aged 15 to 64 years participated in nationally recognised VET, an increase from 24.0% in 2021. The highest participation group in 2022 was students aged 15 to 19 years (45.7%).



In 2022, 25.1% of the male and 23.5% of the female Australian resident population aged 15 to 64 years participated in nationally recognised VET.

# **Funding source**


#### **Students**

VET students can undertake training as a full fee-paying student (domestic or international fee-for-service) or with the assistance of a government subsidy (government-funded).

In 2022, compared with 2021,

- government-funded students decreased by 5.2% to 1.3 million
- domestic fee-for-service students increased by 8.7% to 3.4 million
- international fee-for-service students increased by 6.2% to 226 675.

International-fee-for-service funding is a customised grouping consisting of all international fee-for-service values.

In 2022, the majority of

- government-funded students (83.0% or 1.1 million) were enrolled in training package qualifications
- domestic fee-for-service students (84.5% or 2.9 million) were enrolled in subjects not delivered as part of a nationally recognised program
- international fee for service students (87.8% or 199 125) were enrolled in training package qualifications.


International-fee-for-service funding is a customised grouping consisting of all international fee-for-service values.

### **Full-year training equivalents (FYTEs)**

In 2022, compared with 2021,

- government-funded FYTEs decreased by 3.6% to 529 705
- domestic fee-for-service FYTEs increased by 7.7% to 484 180
- international fee-for-service FYTEs decreased by 7.6% to 135 880.

In 2022, the majority of

- government funded FYTEs (87.8% or 465 080) were in training package qualifications
- domestic fee-for-service FYTEs (61.4% or 297 375) were in training package qualifications
- international fee-for-service FYTEs (96.3% or 130 825) were in training package qualifications.



### Students in nationally recognised programs

In 2022, compared with 2021, the number of students enrolled in nationally recognised programs decreased by 1.3% to 2.1 million:

- government-funded students decreased by 3.4% to 1.2 million
- domestic fee-for-service students increased by 0.9% to 833 640
- international fee-for-service students increased by 0.1% to 207 195.



### Students in subjects not delivered as part of a nationally recognised program

In 2022, compared with 2021, the number of students enrolled in subjects not delivered as part of a nationally recognised program increased by 10.4% to 3.0 million:

- government-funded students decreased by 23.2% to 122 055
- domestic fee-for-service students increased by 11.5% to 2.9 million
- international fee-for-service students increased by 149.0% to 23 395.

# **Training Providers**

#### **Provider counts**

In 2022, there were 3589 registered training organisations (RTOs) that had an active registration and delivered nationally recognised VET.



In 2022, 3.4 million students (76.2%) were enrolled in nationally recognised training at private training providers, 717 760 (15.9%) at TAFE institutes, 493 480 (10.9%) at community education providers, 106 380 (2.3%) at enterprise providers, 103 475 (2.3%) at schools and 67 695 (1.5%) at universities.



In 2022, 732 875 FYTEs (63.7%) were enrolled in nationally recognised training at private training providers, 284 945 (24.8%) at TAFE institutes, 44 550 (3.9%) at community education providers, 35 865 (3.1%) at schools, 32 495 (2.8%) at universities and 19 040 (1.7%) at enterprise providers.

# **Program enrolments and completions**


### **Program enrolments**

In 2022, there were 2.8 million enrolments in nationally recognised programs. Of those, 91.3% were in qualifications, including 84.9% in training package qualifications and 6.4% in accredited qualifications.

#### Compared with 2021,

- training package qualifications decreased by 1.6% to 2.3 million
- accredited qualifications decreased by 2.2% to 177 665
- training package skill sets increased by 14.1% to 108 985
- accredited courses increased by 4.7% to 131 140.

Figure 12 Nationally recognised program enrolments by type of training, 2018 to 2022 ('000)




# **Program completions**

In 2022, there were 801 875 program completions. This number will be revised upwards with subsequent releases of *Total VET students and courses*.

In 2022, there were 801 875 program completions in nationally recognised programs:

- 85.4% in training package qualifications
- 4.7% in accredited qualifications
- 5.9% in training package skills sets
- 4.0% in accredited courses.

Figure 13 Program completions by type of training, 2018 to 2022 ('000)



#### **Qualification enrolments**

In 2022, Management and commerce was the most popular field of education (20.5%), followed by Society and culture (18.3%) and Engineering and related technologies (17.5%).


Figure 14 Qualification enrolments in the top 5 fields of education, 2022 (%)

In 2022, the highest number of qualification enrolments were in certificate III level qualifications (41.5% or 1.0 million), followed by certificate IV (20.2% or 509 935), and certificate II (17.9% or 452 925).

# **Qualification completions**

In 2022, there were 722 510 nationally recognised qualification completions. This number will be revised with subsequent releases of *Total VET students and courses*.

The highest number of qualification completions were at certificate III level (35.9%), followed by certificate IV (21.5%) and certificate II (20.0%) level qualifications.




Figure 16 Qualification completions by level of education, 2018 to 2022 ('000)



# Subject only enrolments


In 2022, there were 7.3 million subjects not delivered as part of a nationally recognised program. The majority were delivered by private training providers (5.8 million or 79.6%).
