## AVETMISS reporting

### Access to AVS

In our previous Bulletin we advised that, where there wasn't one, we would be adding primary contacts in the AVETMISS Validation Software (AVS). This has now been done, with primary contacts being the CEO currently listed on training.gov.au (TGA).

We also updated legal and business names where changes on TGA were noted. If your legal/trading name has not been updated and has changed, please email us the details and we will update them for you.

Please remember to deactivate any AVS users who have left your organisation to ensure that unauthorised USI transcript updates cannot be made.

### Reminder – Quarter 2

The second quarterly collection window for 2022 fee-for-service activity submissions direct to NCVER (covering the period January to June 2022), will be open from **1–12 August 2022**.

If you submit your fee-for-service data via a State Training Authority, (STA) please check directly with them for their submission dates.

### 2022 annual data

A reminder that the reporting window for annual reporting of 2022 fee-for-service AVETMISS data direct to NCVER will open on 1 January 2023 and close on 28 February 2023.

### Submission issues

A number of RTOs this year left their reporting until the final day of a collection period and ran into issues, such as not being able to access AVS or validation errors, which prevented them from submitting on time.

Whilst data cannot be submitted to NCVER until a collection window is opened (e.g. 1 January - 28 February for annual reporting), data can be uploaded and validated at any time.

With validations remaining active in AVS for 28 days (after which they will need to be re-uploaded and validated) we encourage users to validate data, until error-free, ahead of time so that it can easily be submitted when the collection window is open.

## AVS Validation Error 4754

*Activity periods, for Nationally recognised training, cannot overlap where multiple instances exist for a combination of Training organisation identifier ([value]), Unique student identifier ([value]), and Subject identifier ([value])*

This error occurs when a student is reported as attending the same subject more than once in the same reporting period - i.e., a duplicate enrolment. Usually, a student would not attend/pay for the same subject twice in the same period. Where the student is given a *national outcome identifier '20 - Competent' ('70 continuing activity' whilst training)*, the second entry should be reported as *'60 - Credit transfer/national recognition' ('85 not yet started during training)*. The start date for credit transfer should be after the completion/end date of the first entry).

There are instances where a student may attend/pay for training in the same subject more than once in the reporting period (e.g. a first aid course or where they undertake two courses containing the same unit which is delivered in different contexts). If an error occurs in this context please contact Client Support for assistance.
