

Australian vocational education and training statistics

Government-funded students and courses 2021

National Centre for Vocational Education Research

Highlights



In 2021, 1 250 100 students were enrolled in government-funded vocational education and training (VET). They included:

- 1 198 500 students enrolled in nationally recognised training
- 98 400 students enrolled in non-nationally recognised training.

In 2021, compared with 2020:

- students numbers increased by 4.9% to 1 250 100
- full-year training equivalents (FYTEs) increased by 12.0% to 485 300
- students enrolled in nationally recognised VET increased by 5.0% to 1 198 500
 - students enrolled in nationally recognised programs increased by 8.1% to 1 087 700
 - students enrolled in stand-alone nationally recognised subjects decreased by 0.3% to 27 000
- students enrolled in non-nationally recognised training increased by 6.6% to 98 400.

An estimated 7.4% of the Australian resident population aged 15 to 64 years participated in governmentfunded VET in Australia in 2021.

From 2017 to 2021: • student numbers increased by 10.1% to 1 250 100.

Students and participation

In 2021, 1 250 100 students were enrolled in government-funded VET, an increase of 4.9% from 2020.

An estimated 7.4% of the Australian resident population aged 15 to 64 years participated in governmentfunded VET in Australia in 2021. Participation was highest among those aged 15 to 19 years(at 19.7%).


In 2021, 1 198 500 government-funded students were enrolled in nationally recognised VET, consisting of:

• training package qualifications (963 900 or 80.4% of students undertaking nationally recognised VET)

- accredited qualifications (91 400 students or 7.6%)
- training package skill sets (38 100 students or 3.2%)
- accredited courses (36 000 students or 3.0%)
- locally developed skill sets and courses comprised of at least one nationally recognised subject (128 500 students or 10.7%)
- stand-alone nationally recognised subjects (27 000 students or 2.3%).

Note that some students enrolled in one or more programs, others in stand-alone subjects, and some in a combination of both.

Note: The sum of proportions will not add to 100% as a student may have enrolled in multiple types of training in a calendar year.

In 2021, 98 400 government-funded students were enrolled in non-nationally recognised VET, consisting of:

- non-nationally recognised programs (73 400 students)
- non-nationally recognised stand-alone subjects (24 900 students).

In 2021, compared with 2020, the number of government-funded full-year training equivalents (FYTEs) increased by 52 100 to 485 300 (up 12.0%).

Participation rate

In 2021, the overall participation rate for government-funded VET for those 15 to 64 years was 7.4%, up 0.4% from 2020.



Students - Australia summary

In 2021, compared with 2020, the number of government-funded students decreased in New South Wales, and increased in all other states and territories.






Students by training provider

In 2021, 1 518 training providers delivered government-funded VET to 1 250 100 students in Australia, consisting of:

- 652 900 students or 52.2% at TAFE institutes (down 2.7% from 2020)
- 56 600 students or 4.5% at other government providers (up 2.0% from 2020)
- 63 000 students or 5.0% at community education providers (up 7.9% from 2020)
- 434 600 students or 34.8% at private training providers (up 19.5% from 2020)
- 97 400 students or 7.8% at other training providers (up 12.9% from 2020).

Provider type by year

Of the 1 518 providers to offered government-funded training in 2021, the majority (975) were Private training providers.

Program enrolments

In 2021, there were 1 502 600 enrolments in government-funded programs, an increase of 6.7% from 2020.


Of these:

• 79.1% were in qualifications, including training package qualifications (72.2%) and accredited


- qualifications (6.9%)
- 5.1% were in training package skill sets and accredited courses
- 10.2% were in locally developed programs comprised of at least one nationally recognised subject
- 5.5% were in non-nationally recognised programs.


In 2021, Society and culture was the most popular field of education (236 600 or 15.7%) for government-funded program enrolments followed by Engineering and related technologies (219 600 or 14.6%).

In 2021, there were 1 188 800 enrolments in government-funded nationally recognised qualifications (up 9.4% from 2020). The most popular level of education was Certificate III (with 47.7% of all qualification enrolments), followed by Certificate IV (20.1%) and Certificate II (14.0%).






Qualification completions

Preliminary numbers show 332 000 government-funded qualifications were completed in 2021. This number will be revised upwards with the release of *Government-funded students and courses 2022*.

The highest proportion of qualifications completed in 2021 were at Certificate III level (44.9%), followed by Certificate II (19.9%), and Certificate IV (17.8%).




Figure 7 Government-funded students, 2003 to 2021 ('000) - Australia






Figure 8 Government-funded full-year training equivalents, 2003 to 2021 ('000) - Australia
